ZONING ORDINANCE NO. 9 - 2003

AN ORDINANCE to amend the Zoning Map for the Maryland-Washington Regional District in Prince George's County, Maryland.

WHEREAS, Application No. A-9957 has been filed for property described as approximately 5.384 acres of land in the R-E Zone, in the southeast quadrant of the intersection of MD 202 (Largo Road) and Wood Ember Drive, adjacent to the Brock Hall Manor subdivision, identified as 2210 Largo Road, Upper Marlboro, to rezone the property to the R-R Zone; and

WHEREAS, the application was advertised and the property posted prior to public hearing, in accordance with all requirements of law; and

WHEREAS, the application was reviewed by the Technical Staff and the Planning Board, who have filed recommendations with the District Council; and

WHEREAS, a public hearing was held before the Zoning Hearing Examiner; and

WHEREAS, the Zoning Hearing Examiner's recommendations were duly filed with and considered by the District Council; and

WHEREAS, having reviewed the record in this case, the District Council has determined, based on consideration of the entire record, that the subject property should be rezoned to the R-R Zone; and

WHEREAS, as the basis for this action, the District Council adopts the recommendations of the Zoning Hearing Examiner as its findings and conclusions in this case; and

WHEREAS, to protect adjacent properties and the neighborhood, the application is granted subject to a condition requiring site plan review.

NOW, THEREFORE, BE IT ORDAINED AND ENACTED:

SECTION 1. The Zoning Map for the Maryland-Washington Regional District in Prince George's County, Maryland, is hereby amended by rezoning the property which is the subject of Application No. A-9957 from the R-E Zone to the R-R Zone.

SECTION 2. To protect adjacent properties and the neighborhood, and to enhance the coordinated, harmonious, and systematic development of the Maryland-Washington Regional District, Application No. A-9957 is approved subject to the following condition:

 Before a building or grading permit is issued for the subject property, a detailed site plan shall be approved, in accordance with Part 3, Division 9, of the Zoning Ordinance. SECTION 3. BE IT FURTHER ENACTED that this Ordinance shall become effective on the date of its enactment, and the rezoning approved herein shall become effective when the applicant accepts in writing the condition in Section 2.

Failure to comply with the stated condition shall constitute a zoning violation and shall be sufficient grounds for the District Council to annul the rezoning approved herein; to revoke use and occupancy permits; to institute appropriate civil or criminal proceedings; or to take any other action deemed necessary to obtain compliance.

SECTION 3. This Ordinance is effective on the 12th day of November, 2003, the date of receipt of the applicant's acceptance of the condition imposed.
