## ORDER AFFIRMING PLANNING BOARD DECISION

IT IS HEREBY ORDERED, after review of the administrative record, that the

decision of the Planning Board in PGCPB No. 06-09, to approve a detailed site plan,

SP-05025, for a self-service car wash facility, on approximately 1.10 acres of land in the

C-M Zone, on the south side of Bladensburg Road, between its intersections with 40<sup>th</sup>

Place to the west and 41<sup>st</sup> Avenue to the east, Colmar Manor, is hereby:

AFFIRMED, for the reasons stated by the Planning Board, whose decision is

hereby adopted as the findings of fact and conclusions of law of the District Council in

this case.

Affirmance of the Planning Board's decision is subject to the following conditions:

- 1. The Detailed Site Plan for the property shall be amended, to provide:
  - a. The car wash shall operate only during the hours of 6:00 A.M. to 11:00 P.M.
  - b. The car wash shall not permit vehicles to cue for car wash services off the property onto any of the streets in the Town, including, but not in any way limited to, 40<sup>th</sup> Place, Newark Road and 41<sup>st</sup> Avenue, and Bladensburg Road. Signs to this effect must be posted and continuously maintained by the property owner. The size and wording of the sign shall be pre-approved by the Mayor and Town Council.
  - c. The landscaping shall be improved along the Newark Road side of the property. The additional landscaping shall be pre-approved by the Mayor and Town Council.
  - d. The vacuums in the rear of the property shall operate only during the hours of 8:00 A.M. to 8:00 P.M.

2. Additionally, Mr. Larisey must agree to support annually two (2) or more Town activities, one of which must include the Port Towns Jobs for Youth program.
