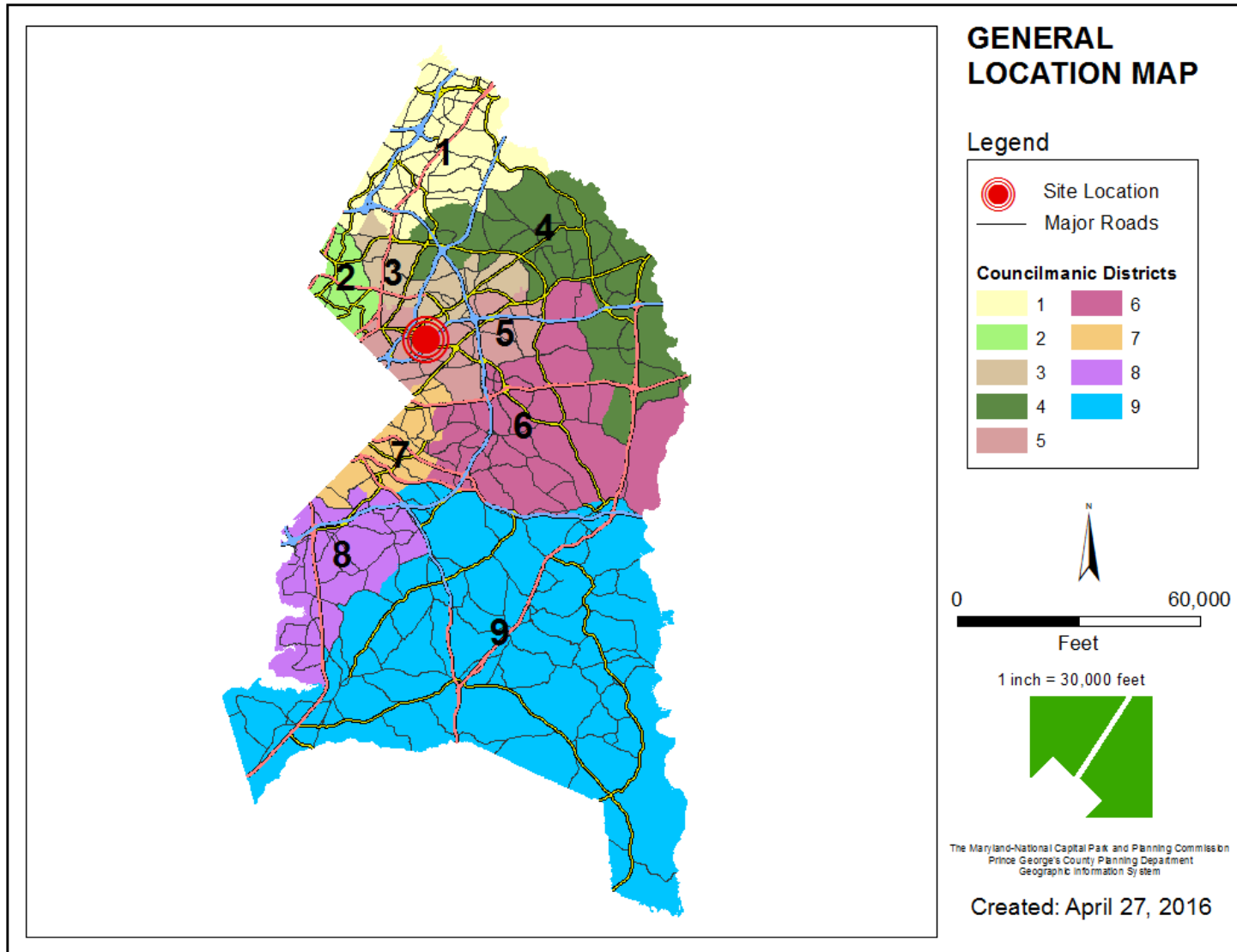

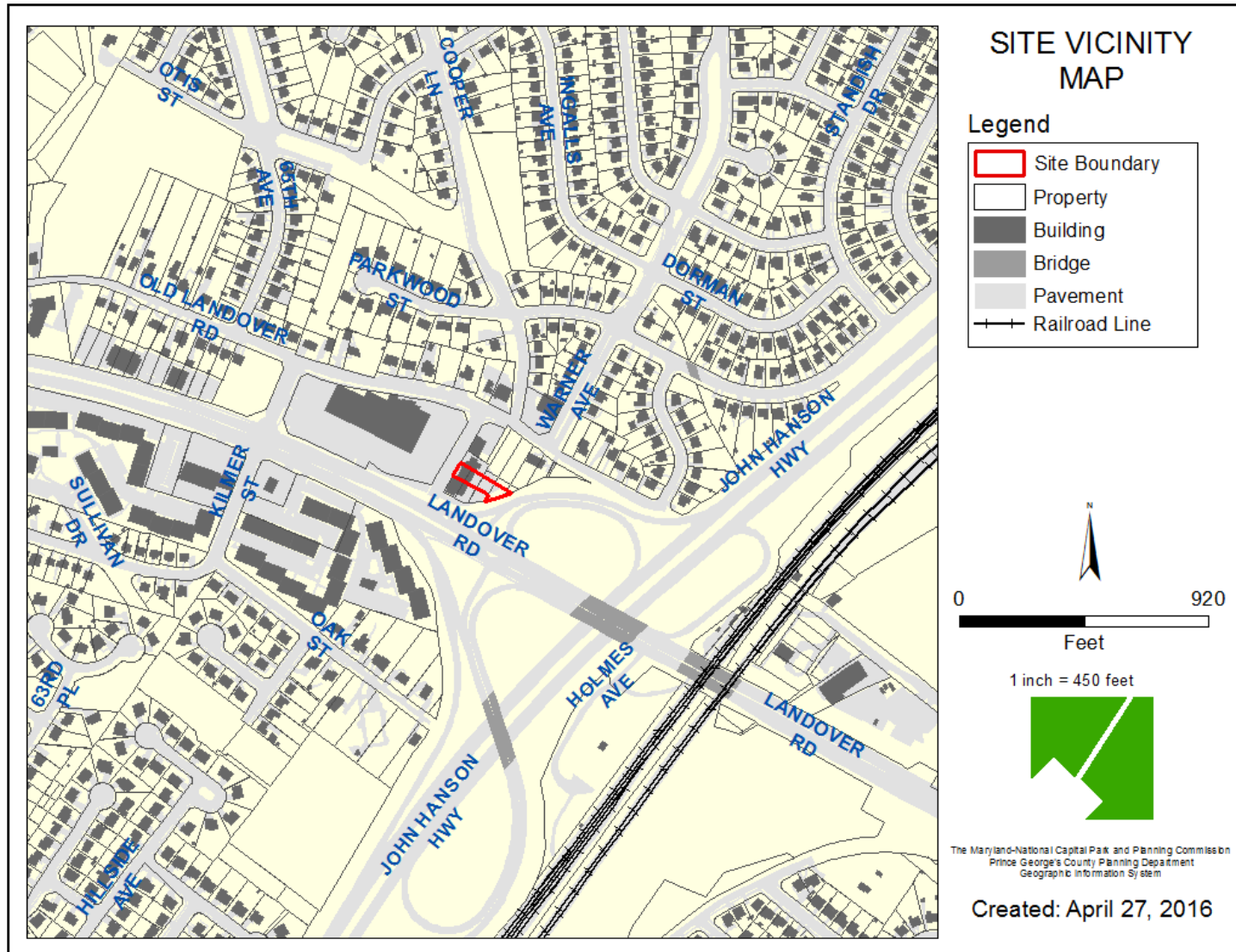

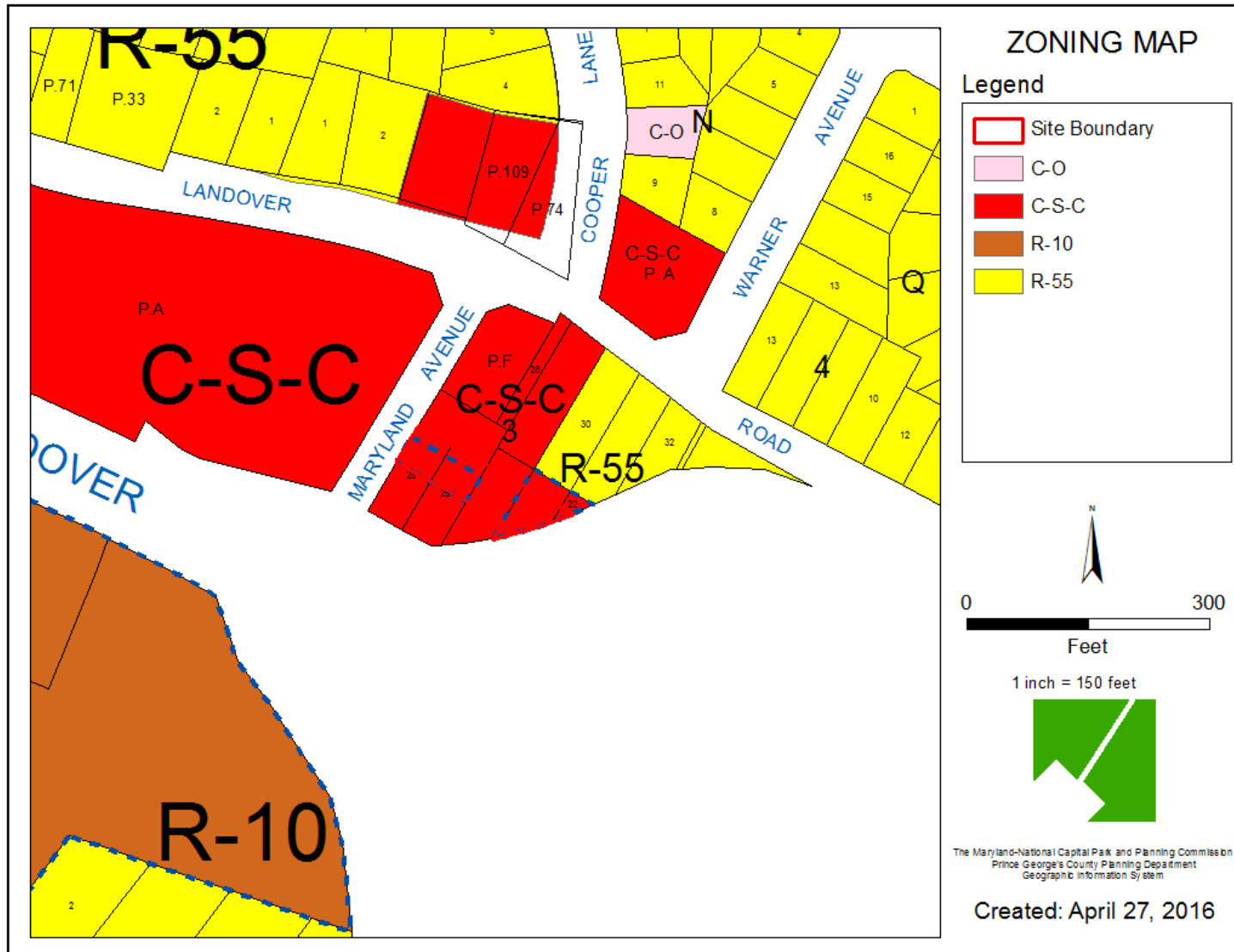
GENERAL LOCATION MAP



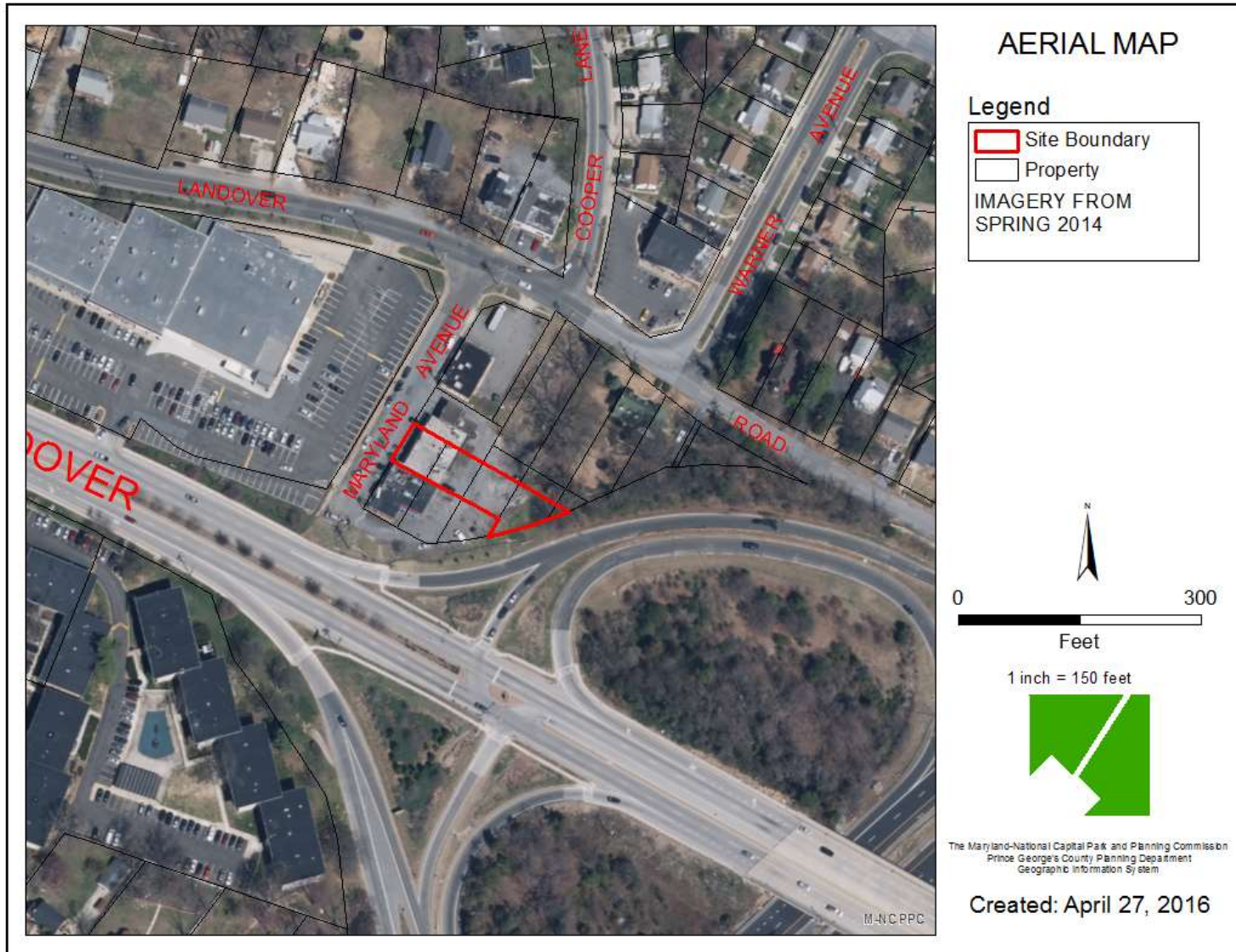
SITE VICINITY



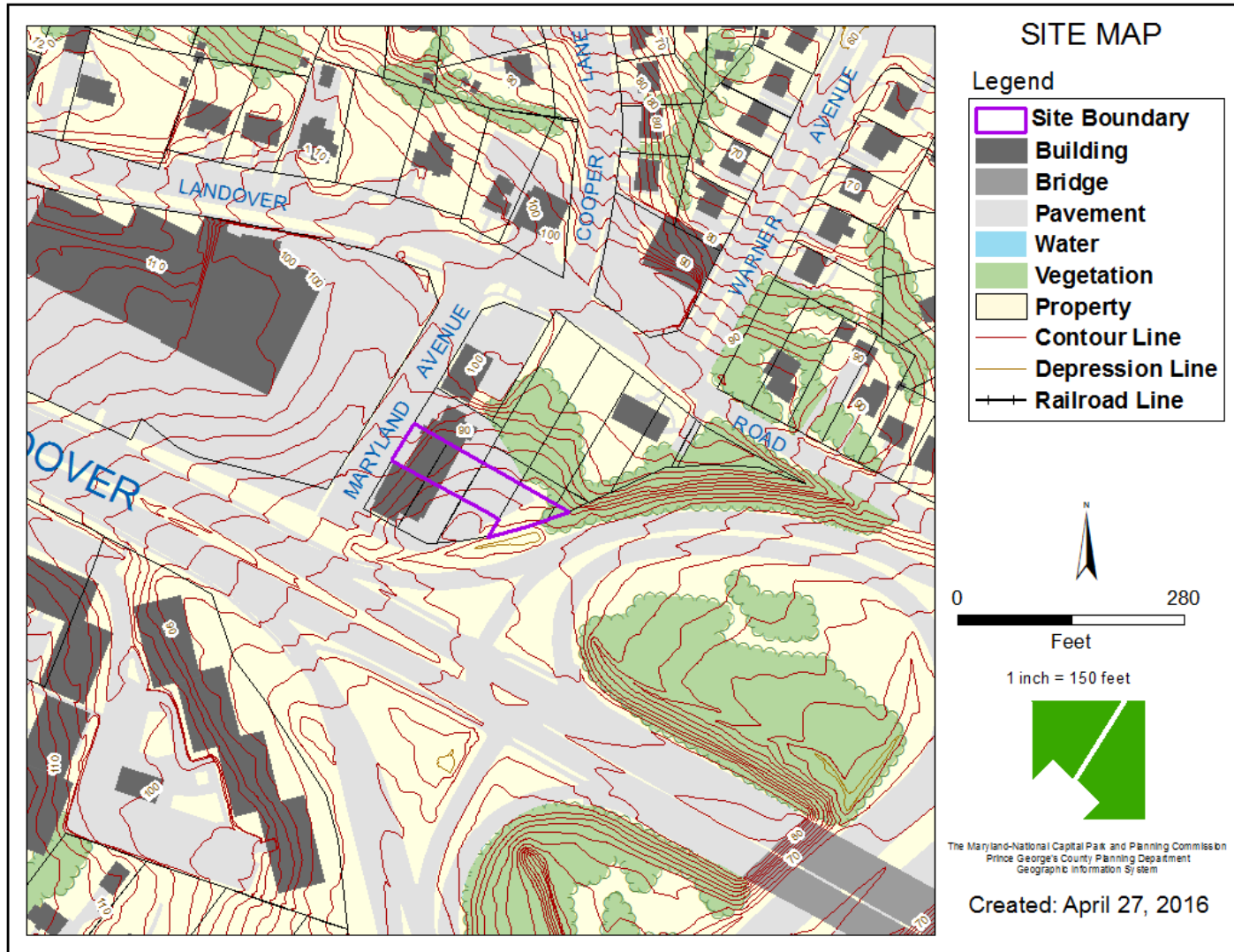
ZONING MAP



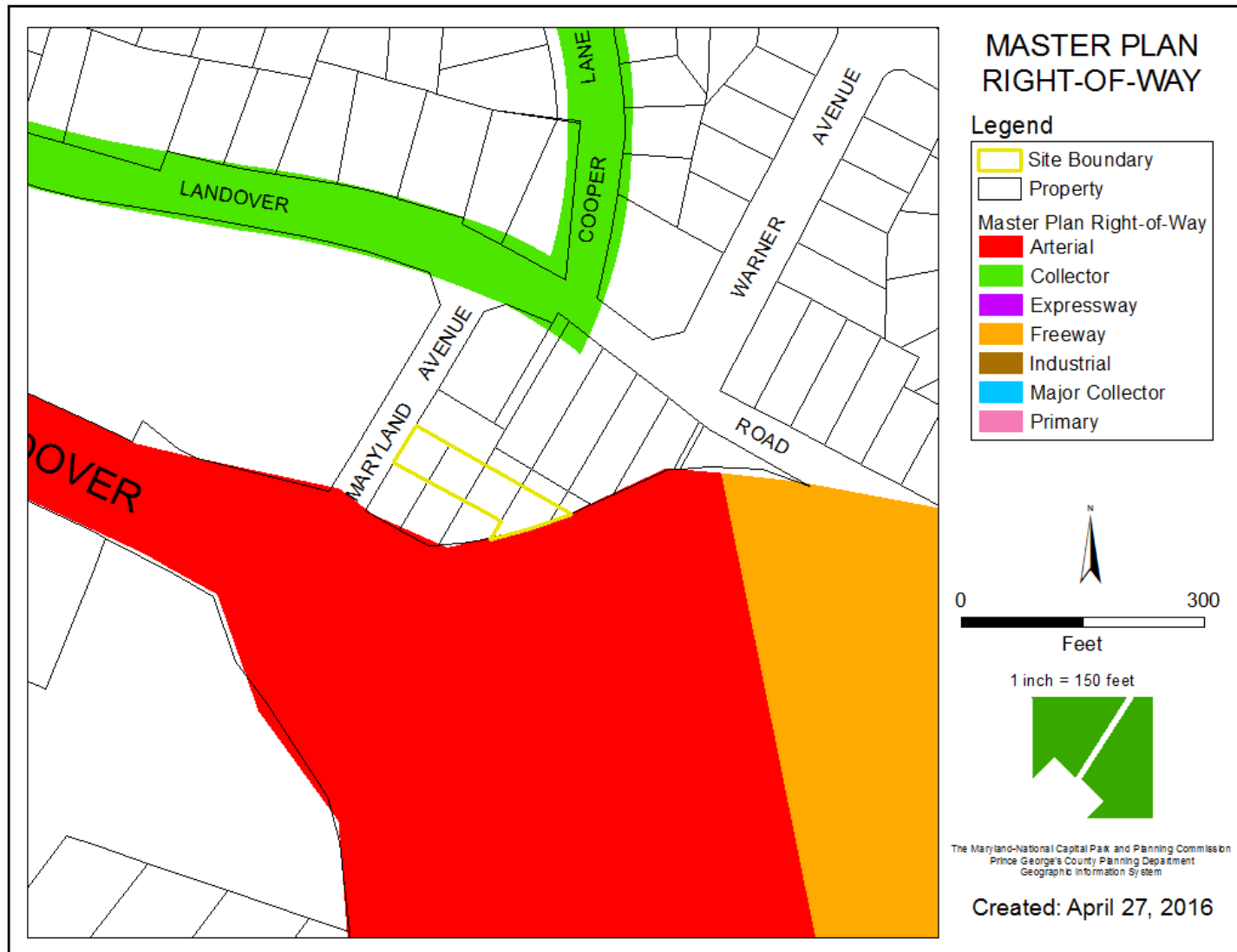
AERIAL MAP

MASTER PLAN RIGHT-OF-WAY MAP

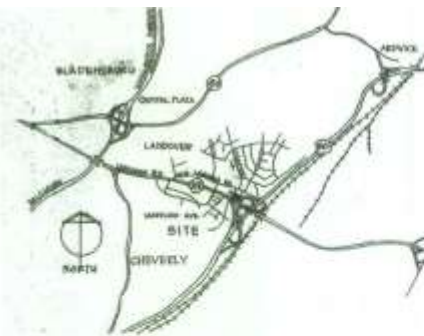


BIRD'S-EYE VIEW

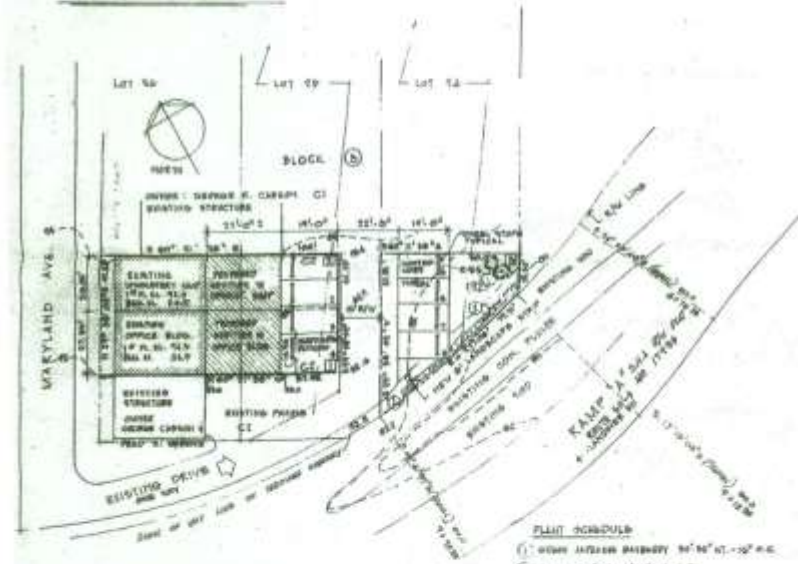

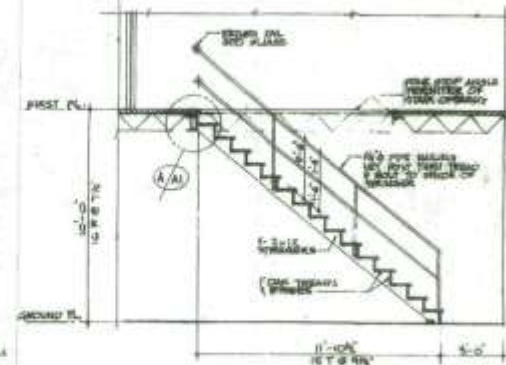

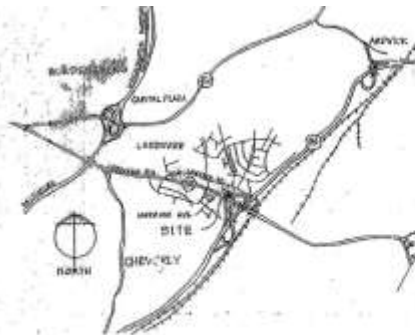

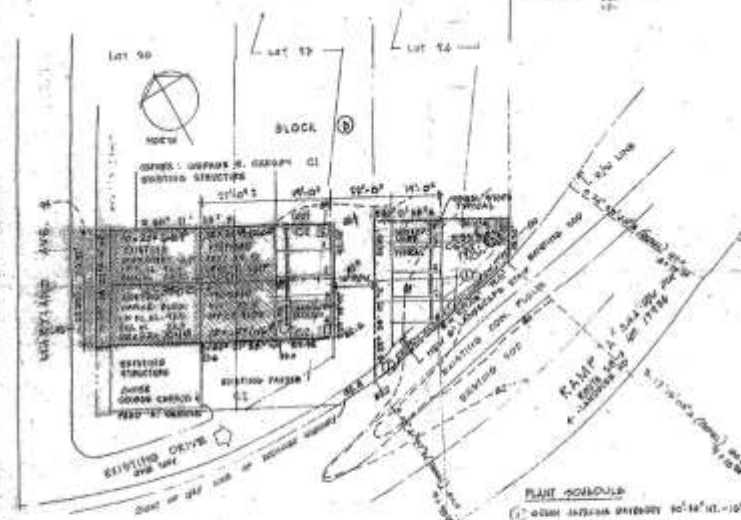

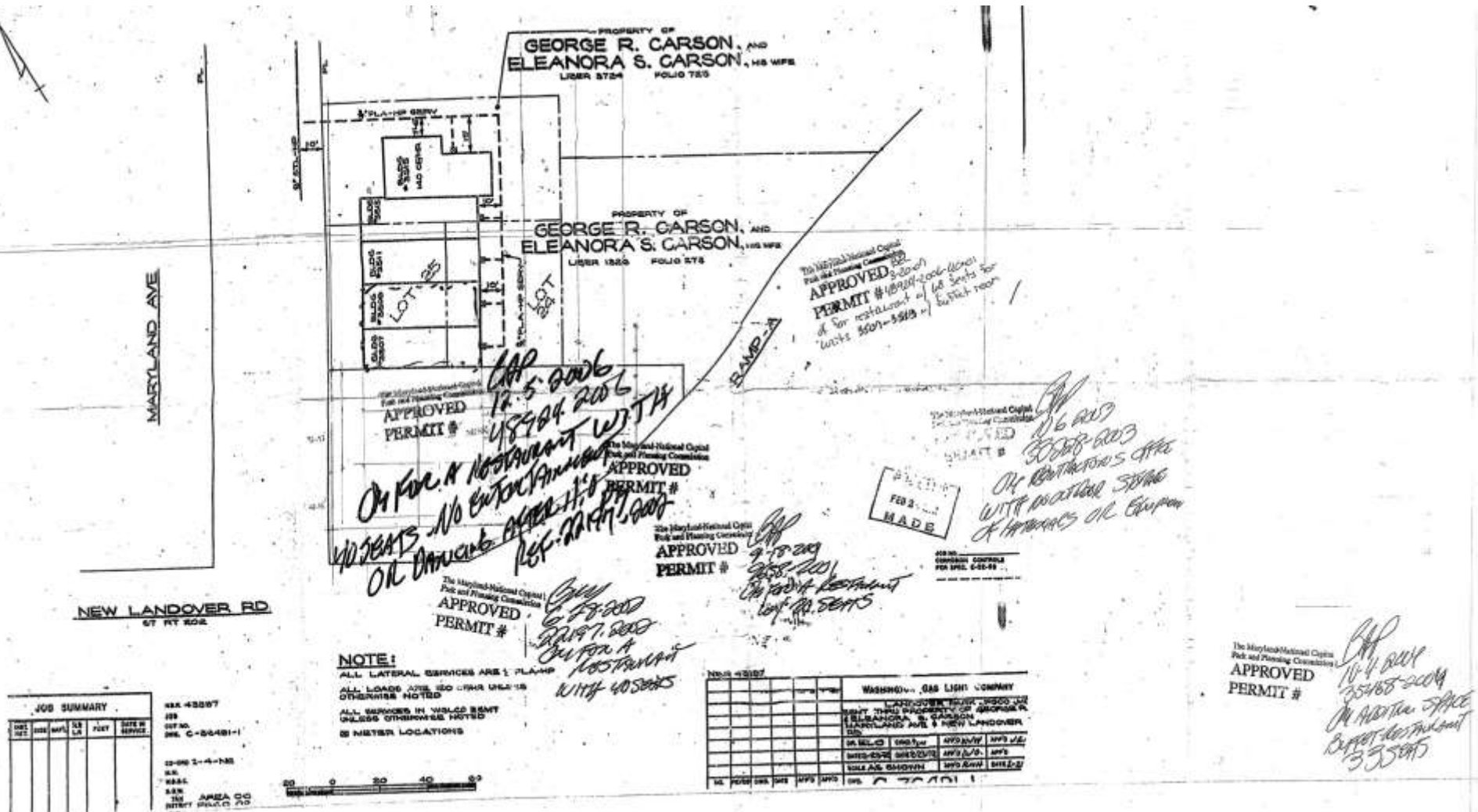
