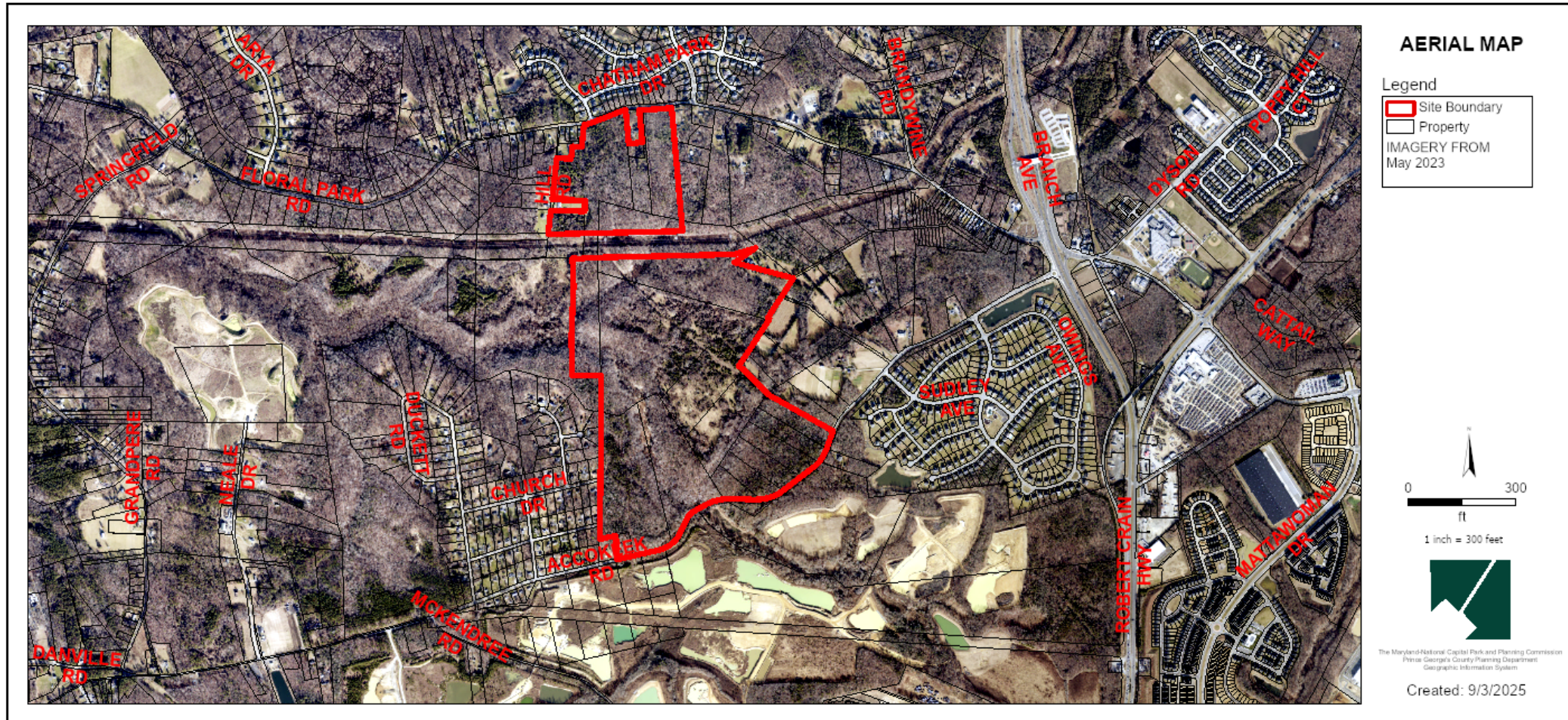

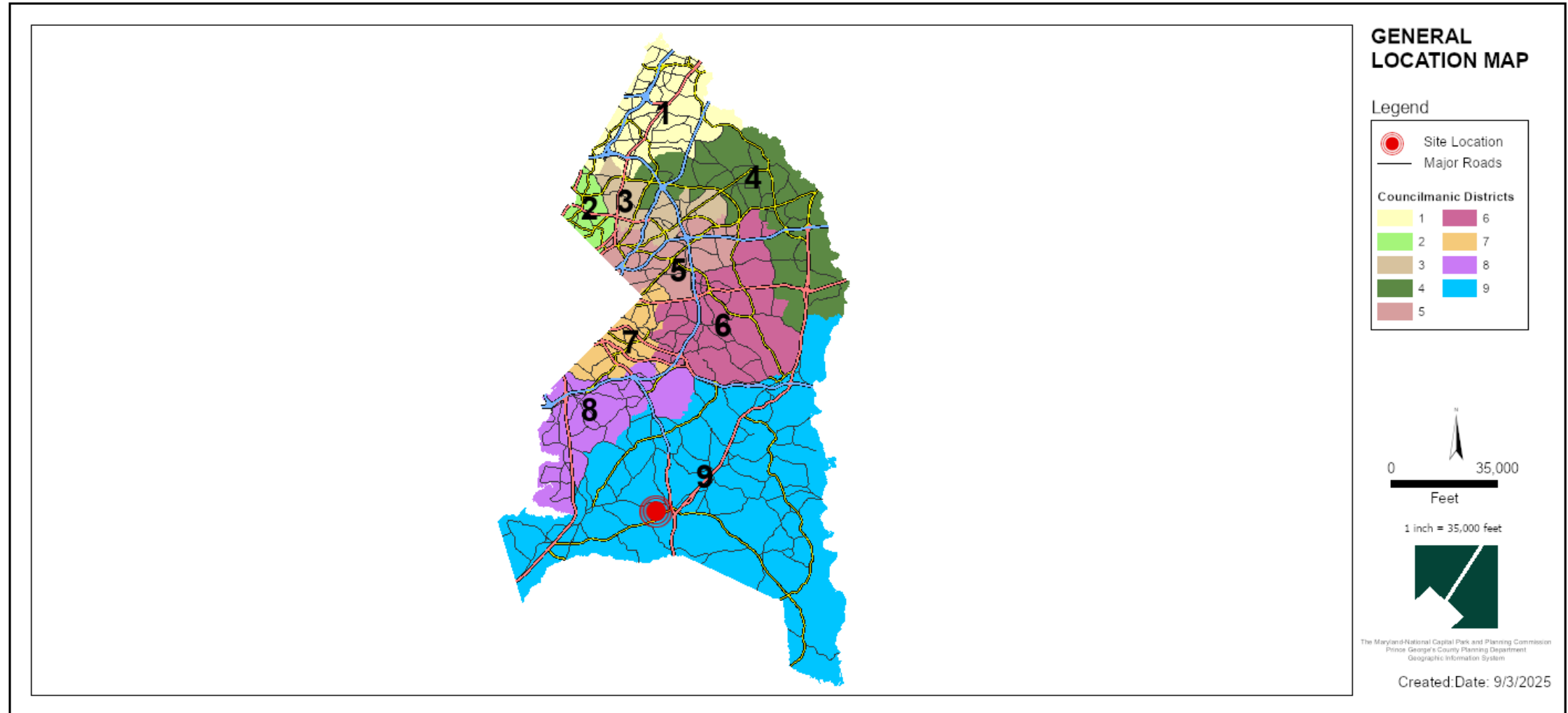

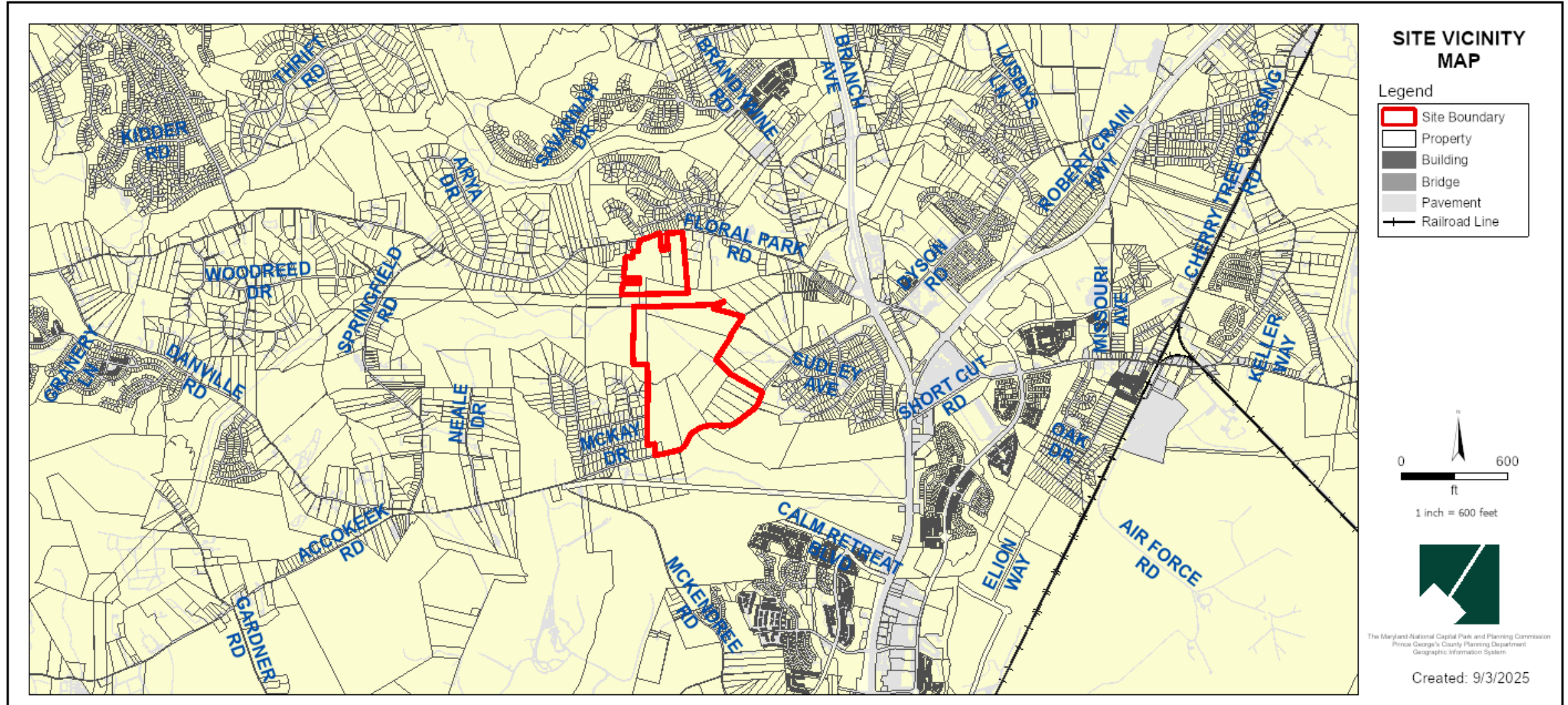
GENERAL LOCATION MAP

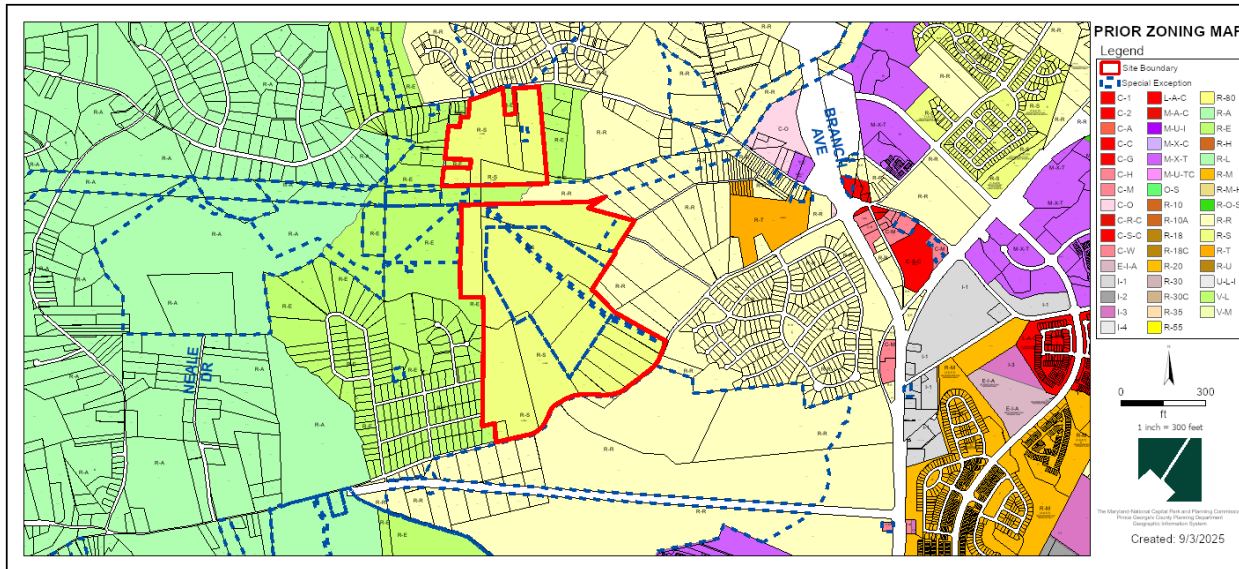


SITE VICINITY MAP

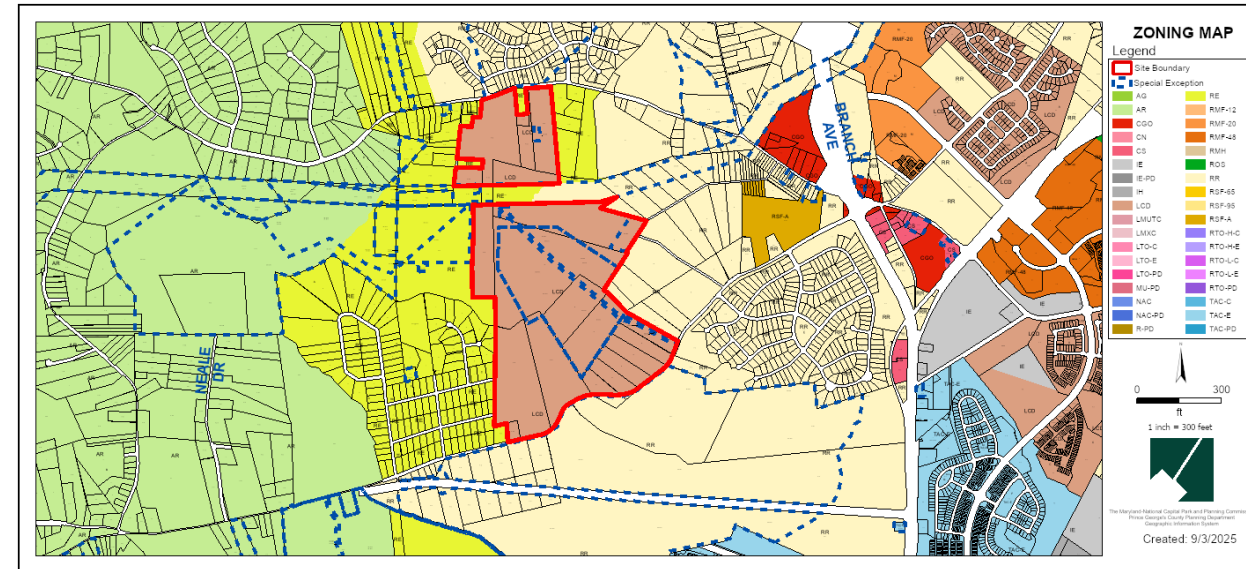


ZONING MAP (PRIOR AND CURRENT)

Prior Zoning Map: R-S

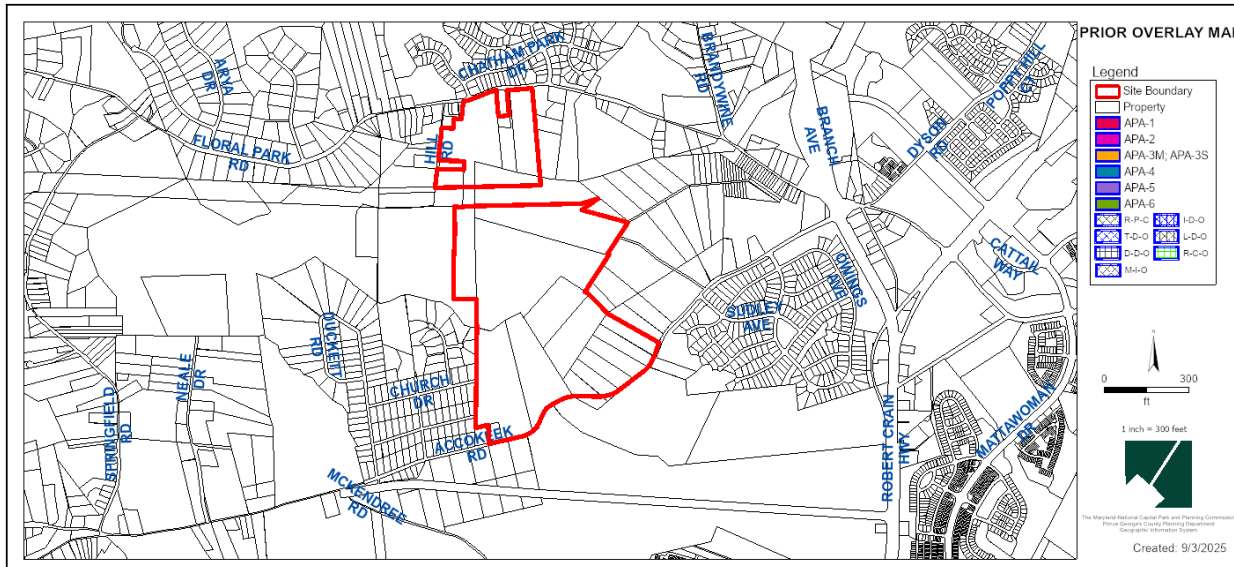


Current Zoning Map: LCD

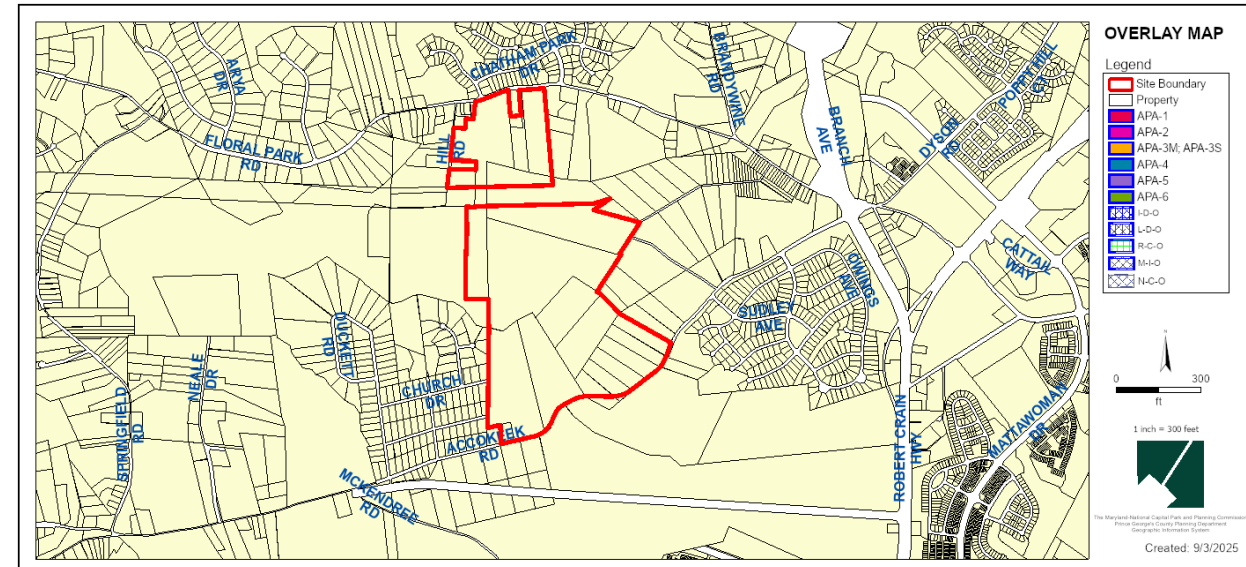


OVERLAY MAP (PRIOR AND CURRENT)

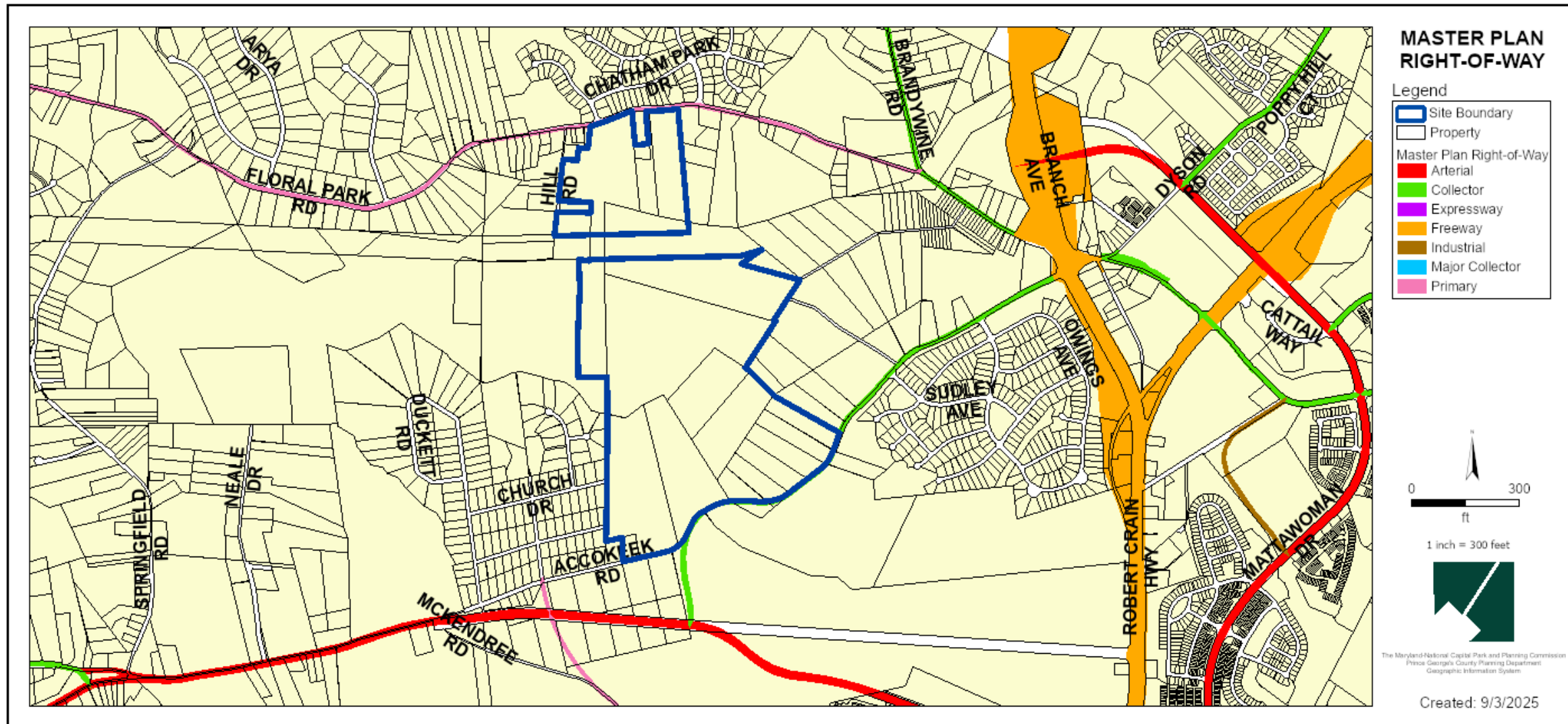

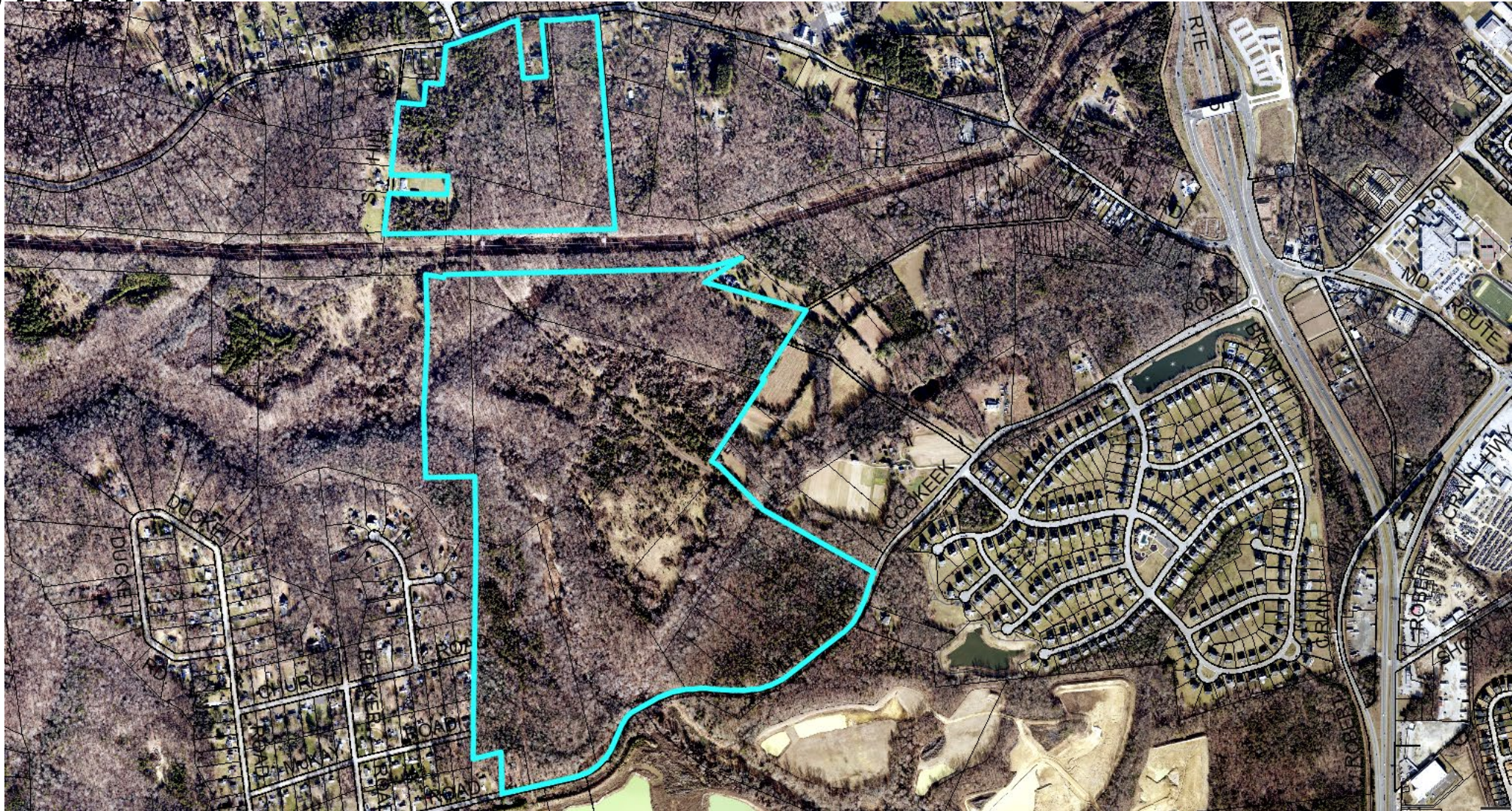
