- 2. The property is located on the west side of Livingston Road, north of Swan Creek Road.
- 3. The final plat(s) of subdivision are in conformance with Preliminary Plan 4-03138, Prince George's County Planning Board Resolution No.04-93.
- 4. The final plat(s) of subdivision are in conformance with detailed site plan DSP-04041, Prince George's County Planning Board Resolution No. 04-292.
