RESOLUTION

WHEREAS, on September 4, 2001, a petition was filed by Joaquim Nazario, Peter and Thessa Lewis and Dravidian Russell for the vacation of part of Williamson Avenue between Lot 20, Block 34 and Lot 2, Block 49 in the subdivision of Oakcrest, such petition, accompanying plat and plat of computation being attached to this Resolution to be considered a part of the Resolution; and

WHEREAS, on or about the year of 1890, said street, Williamson Avneue (50 feet) in width, was created as a public street as part of a subdivision known as Oakcrest, all situated in the 10th Election District in Prince George's County; and

WHEREAS, the Oakcrest Subdivision appears on a plat recorded in Plat Book A•, Plat 108, all among the Land Records of Prince George's County, Maryland; and

WHEREAS, upon consideration of the Petition for Vacation filed herein pursuant to Section 24-112 of the Subdivision Regulations, Prince George's County Code, and it appearing that the petitioners are the owners of all land abutting said street to be vacated; and

WHEREAS, the aforesaid application, also known as Vacation Petition V-01006, was presented to the Prince George's County Planning Board of The Maryland-National Capital Park and Planning Commission by the staff of the Commission on October 11, 2001, for its review and action in accordance with the Regulations for the Subdivision of Land, Subtitle 24, Prince George's County; and

WHEREAS, it appears that signs have been posted on the premises for at least thirty (30) days prior to the date of this action; and

WHEREAS, the staff of The Maryland-National Capital Park and Planning Commission recommended APPROVAL of the Petition; and

WHEREAS, on October 11, 2001, the Prince George County Planning Board heard testimony and received evidence submitted for the record on the aforesaid application.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the provisions of Subtitle 24, Subdivision Regulations, Prince George's County Code, it is hereby directed by the Prince George's County Planning Board that the public street be vacated and reconverted into undivided tracts, parcels of land or acreage subject to the following conditions:

1. Recordation of a subdivision plat in accordance with Preliminary Plan 4-01005.

BE IT FURTHER RESOLVED, that a copy of this Resolution be directed to the Clerk of the Court, Prince George's County, Maryland to note upon the subject plats the fact of this vacation and that the findings and reasons for the decision of the Planning Board are as follows:

1. The public utilities and Prince George's County have been notified of this petition as required by Section 24-112(e) of the Subdivision Regulations.

- 2. The Department of Public Works and Transportation and the Washington Suburban Sanitary Commission have consented to this petition as required by Section 24-112(e)(1) of the Subdivision Regulations.
- 3. No referral agency or department recommended disapproval of the petition.
- 4. No objections were received fro adjacent property owners.
- 5. Petitioners are the owners of all land abutting streets proposed to be vacated.
- 6. The property being vacated shall be conveyed or revert to the ownership of Joaquim Nazario, the applicant of Preliminary Plan 4-01005
- 7. It is the applicant intention to prepare a new subdivision plat in accordance with Preliminary Plan 4-01005 to include the vacated area.

BE IT FURTHER RESOLVED, that an appeal of the Planning Board*s action must be filed with the Circuit Court for Prince George*s County within thirty (30) days following the adoption of this Resolution.
