## RESOLUTION

WHEREAS, on September 15, 2003, a petition was filed by Alexander Matthews for the vacation of Jag Court in the subdivision of Drula Estates, such petition, accompanying plat and plat of computation being attached to this Resolution to be considered a part of the Resolution; and

WHEREAS, on or about June 1991, said street, Jag Court (50 feet) in width, was created as a public street as part of a subdivision known as Drula Estates, all situated in the 11th Election District in Prince George's County; and

WHEREAS, the Drula Estates Subdivision appears on a plat recorded in Plat Book 158, Plat 81, all among the Land Records of Prince George's County, Maryland; and

WHEREAS, upon consideration of the Petition for Vacation filed herein pursuant to Section 24-112 of the Subdivision Regulations, Prince George's County Code, and it appearing that the petitioners are the owners of all land abutting said street to be vacated; and

WHEREAS, the aforesaid application, also known as Vacation Petition V-03006, was presented to the Prince George's County Planning Board of The Maryland-National Capital Park and Planning Commission by the staff of the Commission on October 16, 2003, for its review and action in accordance with the Regulations for the Subdivision of Land, Subtitle 24, Prince George's County; and

WHEREAS, it appears that signs have been posted on the premises for at least thirty (30) days prior to the date of this action; and

WHEREAS, the staff of The Maryland-National Capital Park and Planning Commission recommended APPROVAL of the Petition; and

WHEREAS, on October 16, 2003, the Prince George's County Planning Board heard testimony and received evidence submitted for the record on the aforesaid application.

NOW, THEREFORE, BE IT RESOLVED, that pursuant to the provisions of Subtitle 24, Subdivision Regulations, Prince George's County Code, it is hereby directed by the Prince George's County Planning Board that the public street be vacated and reconverted into undivided tracts, parcels of land or acreage subject to the following conditions:

1. Recording final plats of subdivision in accordance with Preliminary Plan 4-03023.

BE IT FURTHER RESOLVED, that a copy of this Resolution be directed to the Clerk of the Court, Prince George's County, Maryland to note upon the subject plats the fact of this vacation and that the findings and reasons for the decision of the Planning Board are as follows:

- 1. The public utilities and Prince George's County have been notified of this petition as required by Section 24-112(e) of the Subdivision Regulations.
- 2. The Department of Public Works and Transportation and the Washington Suburban Sanitary Commission have consented to this petition as required by Section 24-112(e)(1) of the Subdivision Regulations.
- 3. The public utilities and Prince George's County have been notified of this petition as required by Section 24-112(e) of the Subdivision Regulations.
- 4. The Department of Public Works and Transportation consented to this petition as required by Section 24-112 (e).
- 5. The Washington Suburban Sanitary Commission consented to this petition as required by Section 24-112(e)(1) of the Subdivision Regulations.
- 6. Proposed vacation area does not include road dedication by Plat VJ158-81 on Dyson Road.
- 7. No referral agency or department recommended disapproval of the petition.
- 8. No objections were received from adjacent property owners.
- 9. Petitioners are the owners of all lots abutting the subject street.
- 10. The final plat of resubdivision pursuant to preliminary plan 4-03023 for the lots shown on Plat Book 158, Plat 81 must accompany this Vacation Petition to Land Records.

BE IT FURTHER RESOLVED, that an appeal of the Planning Board\*s action must be filed with the Circuit Court for Prince George\*s County within thirty (30) days following the adoption of this Resolution.
