

Waiver of the Rules of Procedure and Reconsideration Request

Heathermore

By letter dated May 10, 2018, Michele La Rocca, Esq., representing the applicant, Heathermore Associates, LP, requested a waiver of the Prince George's County Planning Board's Rules of Procedure (Section 10(a)), which requires that a reconsideration request be submitted no less than 14 calendar days after the date of notice of the final decision. In this case, the resolution of approval (PGCPB Resolution No. 11-99(C)) was adopted by the Planning Board on October 20, 2011, mailed out on November 22, 2011, and corrected on February 3, 2012. If the waiver is granted, the applicant requests a reconsideration to delete Condition 18 due to other good cause, in furtherance of substantial public interest (Section 10(e)). However, after the request was analyzed, it was determined that Condition 18 and Finding 9, related to adequate transportation facilities, be amended.

The preliminary plan of subdivision approval (PGCPB Resolution No. 11-99(C)) included Condition 18 and Finding 9, which required improvements at the intersection of US 301 (Robert Crain Highway) and MD 382 (Croom Road).

As set forth in the applicant's request, the Maryland State Highway Administration has determined that the off-site transportation improvements at the intersection of US 301 and MD 382 are no longer desired.

If the Planning Board grants the applicant's request for reconsideration, staff is prepared to move forward on the same day with the hearing on the merits of the reconsideration, due to the facts of this specific case, if determined appropriate by the Planning Board.
