Staff recommend a continuance of Preliminary Plan of Subdivision 4-23012, for Renewal Christian Center, which is scheduled for the Prince George's County Planning Board hearing date of June 25, 2024. This application was previously continued from the Planning Board hearing date of June 13, 2024, to allow additional time to satisfy the referral and coordination of reservation for the master-planned right-of-way of US 301 (Robert Crain Highway), which falls on the subject property. Coordination with County and state agencies is required by Section 24-139(b) of the prior Prince George's County Subdivision Regulations, in effect prior to April 1, 2022, which is applicable to this review.
