

Planning Board Agenda October 3, 2024—Request for Continuance

Staff recommend a continuance of Preliminary Plan of Subdivision (PPS) 4-23040, Stephen's Crossing at Brandywine, which is currently scheduled for the Prince George's County Planning Board hearing date of October 3, 2024. Additional time is needed to evaluate the adequacy of public facilities, which is required prior to approval of a PPS, and to ensure timely processing of the technical staff report. Staff recommend a continuance of the Planning Board hearing to October 17, 2024.

If a continuance is granted, additional posting will not be required. The public hearing notice signs for this application were posted on the subject site on September 3, 2024.
