SUBJECT: Comprehensive Design Plans CDP-9902-03 and CDP-9903-02, Oak Creek Club
Request for a waiver of filing fees

In a letter dated March 7, 2011, Norman Rivera and Chris Hatcher, representatives of the applicant (Oak Creek Club Corporation) requested filing fee reductions for Comprehensive Design Plans CDP-9902-03 and CDP-9903-02 from \$25,000 and \$4,800, respectively, to the base fee of \$3,000 for each comprehensive design plan, for a total of \$6,000. The applicant's justification for the requested waiver is that the full fee in each case is an undue hardship when viewed in relation to the minor change requested in the same condition of approval that is attached to both comprehensive design plans. Additionally, the applicant noted that the Zoning Ordinance states that the purpose of the fee is to "defray the costs related to the processing of the application," which in these applications is very limited in scope.

Additionally, staff recognizes that time, effort, and cost efficiencies result from simultaneous review of two comprehensive design plans for the same overall site. For the foregoing reasons, staff supports the applicant's request.

RECOMMENDATION

The Urban Design Section recommends a reduction to the base fee of \$3,000 for each comprehensive design plan, for a total of \$6,000.
