SUBJECT:	Request for Waiver of Filing Fee for a Chesapeake Bay Critical Area Conservation Plan, Variances and Sign Posting Fee Lagana Property–CP-10004

The applicant is requesting a waiver of the filing fee for a Chesapeake Bay Critical Area Conservation Plan application, including several variances and the sign posting fee. The applicant (Daniel and Kimberlie Lagana) were cited in 2007 for building a screened pavilion structure on their property in Eagle Harbor without permits. A conservation plan must be approved by the Planning Board before permits can be issued validating the existing structure because the site is in the Chesapeake Bay Critical Area (CBCA).

The applicant states that the \$730.00 filing fee represents an undue financial hardship. The applicant is petitioning the Planning Board for a waiver of the entire filing fee and sign posting fee.

Section 27-125.02(m) of the Zoning Ordinance authorizes the Planning Board to waive filing fees under the following scenarios:

(4) **Refunds and waivers.**

- (A) No part of a fee shall be refunded or waived unless the Planning Board determines that one (1) of the following applies:
 - (i) The fee was paid by mistake, and the applicant has requested (in writing) a refund.
 - (ii) The application is filed by (or on behalf of) any department or agency of the County, or any municipal, State, or Federal government, except as otherwise provided.

It does not appear that the applicant's situation fits under either scenario.
