The application for Chinese Bible Church of College Park (DSP-09010), continued to the Planning Board hearing date of June 24, 2010, is subject to the 2009 Central US 1 Corridor Sector Plan and Sectional Map Amendment. County Council Resolution CR-50-2010, approving the 2009 Central US 1 Corridor Sector Plan, was adopted on June 1, 2010. Text Amendment 22 in Council Resolution CR-50-2010 removes the existing residential neighborhoods and the R-55-zoned properties of Autoville North and South, in which the Chinese Bible Church is located, from the Development District Overlay (D-D-O) Zone. While the resolution has not been signed by the Council Chairman at the time of the writing of this memorandum, it is the understanding of Community Planning Division and Urban Design staff that the subject site is **no longer part of or subject to** the D-D-O Zone standards in the 2002 Approved College Park US 1 Corridor Sector Plan and Sectional Map Amendment.

Detailed site plan review is not otherwise required for the church which is located in the R-55 (One-Family Detached Residential) Zone and has over four acres of property. The applicant has expressed the intent of withdrawing the DSP application once the resolution has been signed.
