In a letter dated November 13, 2009, the applicant, granting a 70-day waiver, requested a continuance of the Planning Board hearing currently scheduled on December 3, 2009 to January 14, 2010. The stated reason for this request is to afford additional time to work on issues of tree preservation and utility location and to assess the impacts on the site plan design. Staff notes that the issue of provision of adequate recreational facilities forms another basis for this request.

RECOMMENDATION

The Urban Design staff recommends that the request for continuance of Detailed Site Plan DSP-09013 be APPROVED and the case be continued to the Planning Board hearing date of January 14, 2010.
