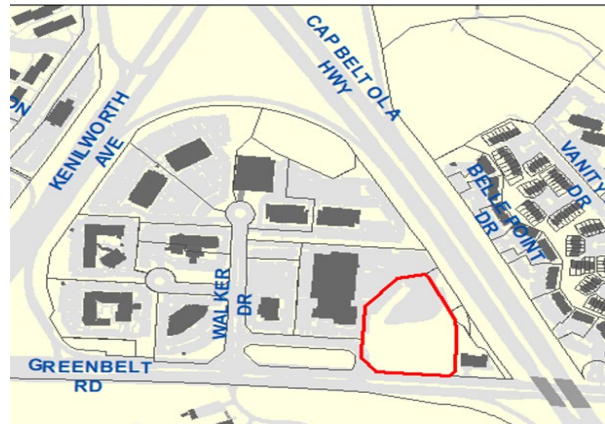

Royal Farms Greenbelt – DSP-19045

By letter dated November 18, 2020, Thomas H. Haller, on behalf of the applicant RF Greenbelt RE, LLC, requested reconsideration of the Prince George's County Planning Board's decision to approve DSP-19045, Royal Farms Greenbelt. The resolution of approval (PGCPB Resolution No. 2020-154) was adopted on November 12, 2020 and mailed out on November 17, 2020. On December 3, 2020, the Planning Board granted the applicant's request for reconsideration, in accordance with Section 10(e) of the Rules of Procedure, based on other good cause, and in furtherance of the public interest.

The applicant's request does not include any specific modifications to the Planning Board's decision on DSP-19045. Instead, this reconsideration is intended to provide persons of record with an additional opportunity to review and respond to information submitted into the record for DSP-19045 after the publication of the initial staff report.

Staff has republished the record from the October 29, 2020 hearing on DSP-19045 and has not made any changes to its recommendations.
