Dear Mr. Michael Weil:

The Prince George's County Planning Department has reviewed the proposed consolidated 5,909 square foot new Vehicle Operations Addition project, at the 11th Logistical Readiness Squadron's (LRS) complex, located on Joint Base Andrews (JBA). The project site is on a large multi-acre paved area with many existing buildings on the east side of the JBA, off Pennsylvania Avenue. This area of JBA is home to current vehicle operations, maintenance, secure vehicle parking/storage, electric vehicle charging stations among other vehicle related operations. Given the location of the proposed new vehicle operations building, there are no impacts to existing non-vehicle-related uses near the general area.

Because this a federal site, the proposed development is not subject to local environmental regulations; but may be reviewed by the Maryland Department of Natural Resources (DNR) and the Maryland Department of the Environment (MDE) with regards to forest conservation and stormwater management.

The Transportation Planning Section has reviewed the referral noted above. The referral involves a proposal to expand a vehicle operations facility at Joint Base Andrews (JBA). The site is located on the east side of JBA, approximately 1,500 feet northwest of the Pearl Harbor Gate on Dower House Road.

Review Comments

The proposed expansion would involve a 5,909 square foot vehicle operations building within JBA. The existing project site is a large multi-acre paved area with several smaller buildings. This area of JBA is home to current vehicle operations, maintenance, secure vehicle parking/storage, electric vehicle charging stations, and other vehicle-related operations. It is understood that the expansion would involve the consolidation of vehicle operations functions and would not generate new employees. Therefore, no traffic analysis has been requested or supplied. Given that this project would allow consolidation of functions at the site, it is believed that any off-site traffic impact would be minimal.

The site is not within or adjacent to any master plan rights-of-way or facilities.

Conclusion

Aside from noting the requirements and the major features of the plan, the Transportation Planning Section has no comments on this proposal.
